

Participation in these cleanups will become even more important this year. It is still unknown if the Coral Reefer Circus will return to Nissan Pavilion this summer. What is known is that there are a growing number of Virginia Clubs competing for a limited number of reserved club seats at concerts. We have always used a point system to make sure the most active members got the best seats, but now we can expect even active members to get caught in a ticket shortage.

Under the system, helping with the litter cleanups is the fastest way to accumulate points. The points breakdown is:

- Highway Cleanup, 15 pts.
- Charity Events (ex. Megan's Walk, Memory Walk), 5 pt. for donation; 5 pt. for participation.
- Club Events (ex. Bingo, bowling, volleyball), 3 pt. for attending.
- Happy Hours, 1 pt.
- Event Coordinator, 3 pt.
- Event Volunteer, 1 pt.
- Misc. Events (ex. hockey, baseball, sailing), 1 pt.
- Donation of Goods or Services, 1 pt.

Points are recorded per membership (not per member) and are tallied on the club's fiscal year from July 1-June 30. Sally Hernley will be working to bring the points database up to date before we get the word on tickets (hopefully)

in March or April.

The Administration Committee is also looking for ideas and volunteers to help with welcoming new members and introducing them to the rest of the crew. We'll be discussing ideas again at our March 2 meeting.

We're also looking for ideas on a good location for a new candy vending machine. The one we have at Scoopers in Leesburg has generated hundreds of dollars for the Save the Manatee Club. If your business has a high traffic area where the machine can be placed and easily maintained, let us know.

# Feb. 10 Event Helps St. Jude's

On Saturday, Feb. 10, artist J Douglas will don his Taekwondo gear to lead kick-a-thon to benefit St. Jude Children's Research Hospital.

Students from J's Tiger Claw Taekwondo studio will be working from noon to 4 p.m. To break last year's record of raising \$2,700. This year's goal is \$5,000 and if that threshold is met J will shave his head in honor of the incredible work that St. Jude Hospital does everyday.

St. Jude Children's Research Hospital is supported primarily by public contributions and is the leading center for the study of diseases such as cancer, sickle cell anemia, thalassemia, and pediatric AIDS. It's research findings are freely shared worldwide. Admission for children is based on physician referral and determination that the

illness is under study at St. Jude. St. Jude covers all costs not covered by insurance. Families without insurance are never asked to pay.

The event kicks off at 12 noon. Leesburg Town Mayor, BJ Webb, will kick the first pad. If you haven't seen J break cinderblocks with his bare hands before, now is the time. Board breaking demonstrations (wood donated by Home Depot) will run from 12-1 p.m. Then starts "kick till you drop" until 4 p.m. When Dominoes will be donating several pizzas for refreshments. The event is open to the public and you're invited.

### Parrot Head Club Plates Will Have To Wait

Virginians have always been known as being conservatives. While this might be true in general Virginians are also vain. Just look at the number of vanity plates that are on the roads. In addition to these Virginia has a growing number of specialty plates available for members of certain groups.

Having one of those vanity tags, and knowing how difficult it can be to find the right message, and finding one that is available, I thought it would be a great idea to have a Parrot Head Specialty tag. Virginia has seven clubs recognized by Parrot Heads in Paradise. In addition are the fans who are unaware of our existence and those who don't have a local club. I thought getting the 350 prepaid applicants would be easy.

Armed with the idea, in December I contacted my local delegate's office. I explained our club's history and detailed some of our charitable causes to Robert Marshall's assistant. I was told that he would contact me to get more information. I didn't hear anything until January when I received a call telling me that Delegate Marshall had introduced the bill. Little did I know what was to follow.

After hearing confirmation that the bill was introduced I began thinking of a design. It made sense to use the PHIP logo since Virginia has multiple clubs. I asked Norman to contact them to try and obtain permission to use their logo. PHIP's response was that the term "Parrot Head" and their logo, are trademarks, owned by Jimmy Buffett. Parrot Head Clubs are licensed to use the terms in a very limited way. Elizabeth Teague, president of PHIP, suggested that we contact someone at Margaritaville or Buffett's assistant Mike Ramos, to try to get Jimmy's permission. This is where it got interesting.

I sent a note to Chris Wilson, webmaster of the Church of Buffett website, Margaritaville, and Mike Ramos. Chris posted my letter on his website which generated positive feedback from his readers. Margaritaville forwarded my note to HK Management. Mike Ramos forwarded my note to "the proper people." At this point PHIP decided that it might be better for them to handle the communications with Margaritaville, which was our feeling all along.

While trying to get the trademark issue resolved the bill was making its way through the Virginia General Assembly. It had been referred to the Transportation Committee. While in a subcommittee I drove to Richmond to testify and support the bill. This was interesting to say the least. I had visions of Ollie North during the Iran-Contra Hearings and had no idea what to expect. When I was called to support the bill two members (including Chairman Wardrup) gave me the "Fins Up" signal. The bill was quickly reported out to the full Transportation Committee. Before leaving I was told by Chairman Wardrup that he was very skeptical about this bill when he first read it. After hearing about our charitable causes he thought that our plate deserved to be passed more that some plates that were already issued.

Feeling that this was on its way to approval I returned to Northern Virginia only to find out that Margaritaville's response was negative. We were told by Margaritaville, Inc., through PHIP, that we should cease and desist any efforts to get our bill passed. Through subsequent conversations with PHIP we feel that there is a possibility that an agreement can be reached in the future, but not before this legislative session ends.

We could have used the term "Parrothead" which isn't a trademark and which our club has used since at least 1986, however we feel this might antagonize Margaritaville. The last thing we want to do it hurt Virginia's clubs, or any other club. We feel it's best to work with Margaritaville.

Rest assured we won't drop this. We've heard from countless people who support this effort. This would be a great model for other clubs across the country and will call attention to the great work done by PHIP clubs like ours. We've had some press interest as well. There were articles in the Potomac News (Manassas) and the Virginian-Pilot (Hampton Roads.) There were news items on BuffettNews.com and Church of Buffett, Orthodox. Overall I've been pleased with the experience. I know now that once these issues are resolved we will have a great plate for all Virginia Parrot Heads.



## **Annual Report** of the Parrotheads of the Old Dominion (aka Northern Virginia Parrot Head Club)

#### Calendar Year 2000

During 2000, the Parrotheads of the Old Dominion crossed several milestones in expanding its community service activities while enjoying a stable membership base.

The club membership was 100 at the close of the year, down slightly from a high of 110 mid-year. Membership continues to be drawn from a wide swath of Northern Virginia, other areas of the state and nearby communities in Maryland. Dues are \$25 per person/\$40 per household, with renewals set at \$20 and \$30.

The POD exceeded its charity goals for 2000, largely because of its involvement in regional events, including the organization and hosting of two successful fundraising concerts that allowed the club to donate more than \$2,500 to the Alzheimer's Association of Northern Virginia. That contribution allowed the POD to be a title sponsor of the Memory Walk in October.

In the spring, the club, through donations, a bowling event and a bingo night, raised more than \$1,800 to support the Cystic Fibrosis Foundation as part of Megan's Walk.

Contributions to the Interfaith Relief food bank collected throughout the year at each club function totaled \$209 in cash and 900 pounds of food.

The POD expanded its participation in the state's Adopt-A-Highway program, adding a second stretch to road to its litter patrol responsibilities. The club maintains a 2.5 mile stretch of Rt. 15, a state scenic byway south of Leesburg, and a section of Signal Hill Road in Manassas. During six cleanups, POD members spent in excess of 125 man-hours working to keep the roads litter free, collecting 73 bags of trash.

At year's end, POD made a \$625 contribution to the Save the Manatee Club, an amount raised from donations at club functions throughout the year and from special collections from a club-owned candy vending machine and a donation jar at Scooper's deli.

At our holiday party in December, 44 items were collected for the Toys for Tots program.


